Heard Md. F. Faridi, learned counsel appearing for the petitioner. Also heard Mr. A. K. Choudhury, learned counsel appearing for the respondents.

By way of this petition under Article 226 of the Constitution of India, the petitioner is assailing the impugned transfer order dated 09.01.2026, whereby the petitioner was transferred from Tezpur to Srinagar, Jammu & Kashmir in his capacity as GS-191736M Eqpt Mech (Elect).

Md. F. Faridi, learned counsel for the petitioner, submits that the petitioner is suffering from low medical category as would be evident from the medical report enclosed as Annexure 1 to the writ petition. He further submits that petitioner's wife is also suffering from 50% Locomotor disability. In view of the aforesaid circumstances, the petitioner had submitted representations seeking reconsideration of the impugned transfer order. However, by order dated 01.06.2026, the authorities rejected the petitioner's request without giving any reasons thereof.

Issue notice, returnable on 10.08.2026.

Mr. A. K. Choudhury, learned counsel accepts notice for all the respondents.

Extra copy be furnished during the course of the day.

Till the next date of listing, *status quo* with regard to the post presently held by the petitioner shall be maintained.
