Heard Mr. G.N. Sahewalla, learned Senior Counsel assisted by Ms. T. More, learned counsel for the applicant.

2] Mr. G.N. Sahewalla, learned Senior Counsel submits that this Interlocutory Application has been filed seeking deletion of the name of the applicant namely M.P. Agarwala Pvt. Ltd. from the array of respondent as there was no claim from the applicant as respondent in Arb.P. No.40/2026.
