Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the instant case record reveals that the earlier Lawazima Court vide its order dated 16.11.2023 had directed the petitioner to obtain instructions regarding the present addresses of the respondent Nos. 5, 6 & 7.
