Mr. K. K. Parasar, learned Additional Public Prosecutor for the State.

2. This is an application under Section 482 of the BNSS, 2023 praying for granting pre-arrest bail to the applicants in connection with Sonai P.S. Case No. 59/2026 under Sections 108/3(5) of the BNS, 2023.

3. Call for the Case Diary.

4. After considering the facts and circumstances of the case, this Court is of the opinion that, till the production of the Case Diary, the accused applicant No. 2, who is the mother of accused applicant No. 1, should be granted the privilege of interim pre-arrest bail at this stage.

5. Accordingly, it is directed that, in the event of the arrest of accused applicant No. 2, namely, *Hajira Begum Laskar @ Hajira Begum Barbhuiya*, by the arresting authority, she shall be released on interim pre-arrest bail upon furnishing a bail bond of Rs. 30,000/- (Rupees Thirty Thousand only) with one surety of the like amount to the satisfaction of the arresting authority, in connection with Sonai P.S. Case No. 59/2026, subject to the following conditions:

- i. that the accused applicant shall appear before the investigating officer within 10 (ten) days from passing of this order;
- ii. that the accused applicants shall cooperate with the investigation and make herself available before the investigating authority as and when called for; and
- iii. that the accused applicant shall not directly or indirectly try to hamper or tamper with the investigation in the instant case.

6. List this matter again on **23.07.2026**.
