1. Heard Mr. S. M. Sarma, learned counsel for the petitioners. Also heard Mr. J. K. Goswami, learned Additional Senior Government Advocate for the respondent Nos. 1 & 2 and Mr. K. A. Sodial, learned counsel appearing on behalf of Mr. S. K. Talukdar, learned Standing Counsel, Co-operation Department, for the respondent Nos. 3 & 5.

2. This Court has seen the order of the Lawazima Court passed on 20.11.2024, which is quoted herein below:-

“However, the learned counsel Mr. S. M. Sarma has appeared before the Lawazima Court today and submitted that respondent Nos. 2 & 4 is one and the same person, who represents as Secretary, The Assam Flying Club Society (i.e., respondent No.4). In this regard, the petitioner wants to file affidavit in support of their stand. Hence, the matter may be sent to the Hon’ble Court enabling the petitioner to file affidavit.”

3. In view of the aforesaid statement of the learned counsel for the petitioner, let the counsel file an affidavit stating that respondent Nos. 2 & 4 is one and same person who represents as Secretary, the Assam Flying Club Society as no such affidavit has been filed as yet.

4. Mr. S. M. Sarma, learned counsel appearing on behalf of the petitioners seeks some time to file the affidavit in that regard.

5. Mr. Sarma, is allowed 2 (two) weeks’ time to file an affidavit accordingly.

6. List the matter after 2 (two) weeks.
