Mr. J C Chaudhury, learned counsel for the petitioners submits that the

petitioners by filing this writ petition claim for their unpaid Provident Fund and also arrear salary entitled to them as per the revised pay. He further submits that he has filed reply affidavit against the affidavit of respondent No. 2 just two days back. The said affidavit is not found in the record. Office to verify and connect the same to the record.

It is further seen that the petitioner has arrayed the Assam Flying Club as represented by the Registrar, Co-operation Society. Counsel for the State Ms. M Bhattacharjee Addl. Senior Govt. Advocate and Ms. M D Bora, learned Standing Counsel for the Co-operation Department submit that the Assam Flying Club cannot be represented by Registrar, Co-operative Society since the same is a private entity.

Counsel for the petitioner submits that he may be given a weeks' time to obtain instructions and to file an appropriate application seeking amendment of the cause-title, if so advised. Prayer is allowed.

Let the matter be listed again on 3rd of April, 2024. The name of Standing Counsel, Co-operation Department be deleted from the cause-list.
