Heard Mr. G.R. Dutta, learned counsel for the petitioner; Mr. A. Bhattacharyya, learned Standing Counsel, Revenue Department for the respondent no. 1; and Mr. J. Handique, learned Junior Government Advocate, Assam for the respondent nos. 2-4.

Aggrieved by non-implementation of the direction made by the respondent no. 3 in an Order dated 26.05.2025, by the respondent no. 4, the petitioner has approached this Court by the instant writ petition.
