Heard Mr. A Lal, learned counsel for the petitioners. Also heard Ms. G Sarmah, learned Standing Counsel, Railway for the respondent No. 2 in Arb. Pet No. 40/2020.

2. In deference to the earlier order dated 12.06.2026, this Court upon hearing the parties had appointed Justice Pranoy Kumar Musahary, Former Judge Gauhati High Court to act as the sole Arbitrator to arbitrate on the disputes arising by and between the petitioner and the respondents. However, this appointment was subject to the written declaration required to be submitted under Section 12(1) of the Arbitration and Conciliation Act, 1996 by the prospective Arbitrator.

3. The learned prospective Arbitrator has since furnished his written declaration which has been placed before the Court, the same is available in the case record as placed by the Registry.

4. In view of the written declaration which was submitted by Justice Mushahary, the appointment of Justice Pranoy Kumar Musahary, Former Judge Gauhati High Court as the sole Arbitrator made by the earlier order dated 12.06.2026 is hereby confirmed.

5. Justice Pranoy Kumar Musahary, Former Judge Gauhati High Court is appointed as the sole Arbitrator to arbitrate and decide on the disputes arising by and between the parties arising out of the following contract works:
