Perusal of the recent office note dated 05.02.2026 reveals that the notice was issued to the respondent No. 7 by way of registered post with A/D mode on 24.07.2025.

But so far, neither the A/D card nor any un-served notice has been received in regard to the notice issued to the respondent No. 7.

However, it appears that the postal track consignment report regarding the above mentioned notice has been generated and the same has been annexed with the case record at **Flag-'TC' in the Part-III file**.
