Heard Shri A.F.N.U. Mollah, learned counsel for the petitioner.

It is the case of the petitioner that in a recruitment process for appointment of Grade-IV vide an advertisement dated 25.03.2022, the petitioner had applied online under the SC category. However, by mistake, in the column meant for Ex-serviceman, the petitioner had indicated in the affirmative. In the recruitment, the petitioner was selected for appointment vide an order dated 23.05.2023. However, the petitioner was not allowed to join on the aforesaid grounds.

Let notice be issued, returnable on 21.08.2024.
