Heard Shri I. S. Mazarbhuiyan, learned counsel for the applicant, who by means of this application has prayed for modification of the order dated 16.09.2025. By the aforesaid order, a cost of Rs. 5,000/- (Rupees Five Thousand) was imposed on the learned counsel for the petitioner to be deposited in favour of the Gauhati High Court Bar Association Welfare Fund. It was also made clear that the cost was imposed on the counsel and not on the party.

A bare perusal of the order dated 16.09.2025 would disclose that the process of the Court was abused as a mention memo was filed by mentioning the matter as a motion which was allowed even on a hearing day and on the said date, the adjournment was sought for. It was also disclosed that the matter

was of the year 2024 and was not at the motion stage but at the admission stage.

Considering the above, this Court is of the opinion that no case for modification is made out and accordingly the IA stands dismissed.

Shri H. K. Hazarika, learned State Counsel and Shri A. K. Talukdar, learned counsel for the respondent nos. 5 & 6 are present.
