Learned counsel Mr. A. Chetry appears on behalf of Mr. P.D. Nair, learned counsel for the petitioner. Heard.

Perused the records.

The instant matter has been carefully perused and upon such perusal, it has been observed that the notice was issued to the respondent Nos. 4 & 5 by registered post with A/D as well as by usual Court process on 05.04.2025.
