Heard Mr. P P. Borthakur, learned counsel for the applicant and Mr. R. Goswami, learned counsel for the respondent No.1. and Mr. T. Kalita, learned counsel for the respondent No.2.

Mr. P P. Borthakur, learned counsel for the applicant submits that since the parties are duly represented, the MAC. Appeal may be fixed for final hearing and interim order may be continue till the disposal of the appeal.

The prayer is not objected.

In view of the above, and as the MAC.Appeal has already been admitted, the operation of the impugned judgment and order dated 31.03.2018 in MAC. Case. No.2160/2013 in respect of the owner of the vehicle/present applicant is hereby stayed till the final disposal of the MAC.App.No.139/2021.
