ORDER

Date : 07.05.2026

Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the recent office note dated 13.02.2026 reveals that notice was issued to the respondent Nos. 5 to 8 via registered post with A/D mode on 04.08.2025.

But so far, neither the A/D cards nor any un-served notices have been received in respect of the above mentioned notice issued to the respondent Nos. 5 to 8.

However, it has been observed that the postal tracking details regarding the said notices have been generated by the concerned section and the same have been annexed with the case record at **Flag-'TC' in the Part-III file**. These tracking reports reveal the following status:—

Respondent Nos. 5, 6 & 7:— "Item Dispatched" by "Guwahati NSH" as of 07.08.2025.

Respondent No. 8:— "Item Transmitted to Dhirenpara B.O." by "Ambari Fatasil S.O." as of 07.08.2025.

From the said postal tracking report, this Lawazima Court is unable to ascertain whether the notice has been duly served upon respondent Nos. 5 to 8, as no further tracking status is available beyond 07.08.2025.

In view of the observations made above, this Lawazima Court is of the view that fresh

steps shall be taken by the petitioner for effective service of notice upon the respondent Nos. 5, 6, 7 & 8. As such, the petitioner is hereby afforded 7(seven) days time to take fresh steps for service of notice upon the respondent Nos. 5 to 8 by way of speed post mode, in terms of the **Notification No. 85 dated 15th October, 2025 (at Flag-'N')**.

Let the matter be listed again before the Lawazima Court in the on 08.06.2026.
