None appears on behalf of the petitioner.

Perused the records.

Perusal of the recent office note dated 16.11.2025 reveals that notice was issued to the respondent Nos. 3 & 4 by way of registered post with A/D on 05.06.2025.

Now, in respect of the said notice issued to the respondent Nos. 3 & 4, it has been observed as follows:—

Respondent No. 3:— In this regard, it appears that neither the A/D card nor any unserved notice has been received by the concerned section till date.

*However, it appears that the postal track consignment report regarding the above mentioned notice has been generated and tagged with the case record at **Flag-'Q' in Part-III file**.
