Heard Shri A. Ali, learned Counsel for the applicant - writ petitioner, who by means of this application has prayed for impleading the following incumbents as party respondents in the connected writ petition in place of the existing respondent nos. 3 and 4 :-

- (i) District Commissioner, Kamrup (Rural) - respondent no.3.
- (ii) Superintendent of Police (Border), Kamrup (Rural) - Respondent no. 4.

It is submitted that due to inadvertence, the necessary parties were left out and improper parties were arrayed as respondents.

Also heard G. Sarma, learned Standing Counsel, Home Department and NRC as well as Shri P. Sarma, learned State Counsel who do not oppose the aforesaid prayer.
