1. Heard Mr. A.C. Sarma, learned Senior Counsel assisted by Mr. N. Brahma, learned counsel for the petitioner.
2. The petitioner's case is that the petitioner has been given a Trade Licence by the Dhubri Municipal Board and the validity of the said is to be expire on 31.03.2025. However, vide the impugned letter dated 01.08.2024, the petitioner's licence has been cancelled without issuing any prior notice. He submits that the Trade Licence has been cancelled on the ground that the same was found to be incorrect/wrong.
3. Issue Notice returnable in 3 (three) weeks.
4. Mr. K. Gogoi, learned counsel accepts notice on behalf of the respondent nos.1 & 3, while Mr. A. Kalita, learned counsel accepts notice on behalf of the respondent no.2.
5. Petitioner to take steps for service of notice upon the respondent nos.4 & 5 by registered post with AD within the course of the day.

6. List the matter on 09.09.2024.
7. In the interim, the impugned letter dated 01.08.2024 shall be kept in abeyance till the next returnable date.
