Heard Mr. A R Bhuyan, learned senior counsel assisted by Ms. S Laskar, learned counsel for the petitioners. Also heard Mr. H Sharma, learned Additional Senior Government Advocate for the State respondents.

Mr. H Sharma, learned Additional Senior Government Advocate submits that instruction has already been received in WP(C) No. 4081/2026 and accordingly shall file affidavit-in-opposition by the next date of listing, however, instruction is still awaited in respect of the remaining three writ petitions, i.e., WP(C) No. 4021/2026; WP(C) No. 4022/2026 and WP(C) No. 4023/2026.
