Heard Mr. A. Thakur assisted by Ms. J.R. Thakur, learned counsel for the applicant. Also heard Mr. G. Choudhury, learned counsel appearing for opposite parties.

It is submitted by Mr. Choudhury, learned counsel for the opposite parties that after the death of G.L. Agarwalla, under whose name and style the firm namely, M/s. G.L. Agarwalla was operating, the other partners have already been impleaded and he is appearing for them in all these interlocutory applications. Mr. Choudhury, the learned counsel for the opposite parties further submitted

that in the main appeal, the applicants have also made a prayer for stay of execution, to which he may be allowed some time to file his written objection.

Mr. A. Thakur, learned counsel for the applicants have raised no objection in that regard.

Further, considering the submissions made by the learned counsel for the applicants, it is seen that there are some interlocutory applications which are filed for condonation of delay in filing the restoration petition in connection with some of the Arbitration Appeals, which have already been dismissed and apart from that, there are some interlocutory applications which are filed for substituting the legal heirs of the deceased respondent /opposite party. In the same time, it is also seen that the other interlocutory applications are for stay of the execution proceeding.
