Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

A perusal of the recent office note dated 26.03.2026 reveals that notice was issued to respondent Nos. 2, 3, 8 and 11 via registered post with A/D on 14.10.2024.

Meanwhile, it appears that the learned counsels have entered appearance on behalf of the respondent Nos. 2 & 3 by filing Vakalatnama. Also, it may be mentioned that the learned counsel Mr. C. Gogoi has appeared before the Lawazima Court today representing the respondent Nos. 2 & 3. In view of the above, it may be said that **service of notice upon the said respondents (i.e., respondent Nos. 2 & 3) is complete.**

Further, in respect of the notice issued to the remaining respondent, i.e., respondent Nos. 8 & 11, it appears that neither the A/D cards nor any un-served notices have been received by the registry till date. Additionally, the postal tracking reports regarding the said notice are unavailable in the official website of India Post. Consequently, service of notice upon respondent Nos. 8 & 11 cannot be presumed at this stage.

In view of the observations made above, the petitioner is directed to take fresh steps for service of notice upon the respondent Nos. 8 & 11 via speed post mode ***[in terms of the Notification No. 85 dated 15th October, 2025 (at Flag-'N')]***, .

Let the matter be listed again before the Lawazima Court in the first week of May, 2026.
