Case taken up before the Lawazima Court.

Learned counsel Mr. S.M. Sarma appears on behalf of the petitioner. Heard.

Perused the records.

From a careful perusal of the instant case record, it may be observed that the matter was previously listed before the Lawazima Court on 27.11.2025 and vide the order passed on the said date, the petitioner was directed to obtain necessary instructions regarding the present addresses of respondent Nos. 8 & 9, within one week from the date of the said order. The said Lawazima Court dated 27.11.2025 had further directed to list the matter again

before the Lawazima Court.

Pursuant to the order stated above, the matter is listed today with an office note dated 10.12.2025. Let the matter be listed before the Lawazima Court again on 06.01.2026.
