Heard Ms. Sayeda Mazida Begum, the petitioner-in-person. Also heard Mr. D. Nath, learned Senior Government Advocate for the respondents.

Pursuant to the order dated 11.08.2026, the learned District and Sessions Judge, Kamrup(M), Guwahati has visited the Central Jail premises and furnished a report dated 02.09.2026, and perusal of the same, especially paragraph No. 5, indicates that the CCTV system server room was inspected and it was found that recording and storage system were not in operational mode as the hard disks (8TB x 16 device) were found in detached condition from the server.

Registry shall furnish a copy of the aforesaid report to the petitioner-in-person as well as Mr. Nath, learned Senior Government Advocate.

Mr. Nath, learned Senior Government Advocate has also produced an up-to-date status report dated 11.09.2026, and submits that the works of repairing, extension, replacement and servicing of CCTV system at Central Jail, Guwahati have been completed. He also submits that on 12.09.2026, the entire work of repairing, extension, replacement and servicing of CCTV system have been completed.

The petitioner-in-person has filed one additional affidavit.

List the matter on 01.10.2026, for further consideration.

In the meantime, Mr. Nath, learned Senior Government Advocate may file his response in the respect of the prayer made in the additional affidavit filed by

the petitioner-in-person.

The report dated 11.09.2026 produced by Mr. Nath, learned Senior Government Advocate shall be marked as 'A' and tagged with the record.
