- 1.** Heard learned counsel Mr. M Khan for the appellant.
- 2.** The instant appeal under Section 173 of the Motor Vehicle Act, has been preferred by the claimant in MAC case No. 376/2022.
- 3.** The learned counsel submits that the instant appeal has been filed for enhancement of the judgment and order dated 19.05.2026 passed by the learned MACT, Bongaigaon in MAC case No. 376/2022.
- 4.** The learned counsel has taken the ground that the impugned judgment and award is required to be enhanced as the learned Tribunal has not considered the entire medical bills submitted by the claimant. The learned Tribunal has also considered the loss of income as Rs. 7,200/- per month, which is not as per the minimum wages at the relevant time. The appellant has also assailed the impugned judgment and award on the insufficiency of the award on other heads also.
- 5.** Admit the appeal. Call for the records from the learned MACT, Bongaigaon.
- 6.** Issue notice to the respondents.
- 7.** The learned counsel for the appellant shall take step for service of notice

upon the respondents by speed post as well as usual process within a period of 7 days from today.
