Heard Shri IH Saikia, learned counsel for the petitioner, who by means of this writ petition is aggrieved by inaction / delay on the part of the Excise Authorities in the matter of shifting of the "OFF" Shop of the petitioner which is situated at Gopak Road, Kangkan Nagar, Dhemaji Town, Assam.

It is submitted that due to certain dispute with the landlord, there is a requirement to shift the shop for which the petitioner had applied. It is also contended that there are feasible locations where the shop can be relocated in spite of which no action has been taken.

Let notice be issued, returnable on 14.09.2026.

Shri RR Gogoi, learned Standing Counsel, Excise Department accepts notice on behalf of the respondent nos. 1, 2 & 4 and Shri M. Chetia, learned State Counsel accepts notice on behalf of the respondent no. 3. Extra copies of the writ petition be served upon the learned counsel for the respondents within two working days.

Pendency shall not be a bar for the Excise Department to resolve the matter in accordance with law.
