Perusal of the recent office note dated 04.09.2025 reveals that notice was issued to the respondent Nos. 1, 2 & 3 by registered post with A/D on 20.08.2025.

Now, in respect of the aforesaid notice issued to the respondent Nos. 1, 2 & 3, it has been observed as follows:—

Respondent No. 1:— In this regard, it appears that the A/D card has been received bearing the purported signature and the official seal of the said respondent. As such, it may be said that **service in respect of the respondent No. 1 has been completed.**

Respondent Nos. 2 & 3:— In this regard, it appears that neither the A/D cards nor any un-served notices have been received by the concerned section till date.
