Heard Mr. A. K. Das, learned counsel, appearing for the petitioners. Also heard Mr. H. Das, learned counsel, who has entered appearance on behalf of the respondent Nos. 2 & 3 by filing his Vakalatnama yesterday.

2. Mr. Das, has prayed for 10 (ten) days time to file his affidavit-in-opposition to the contents of the writ petition.

4. The respondent may file their affidavit-in-opposition within 10 (ten) days from today by supplying a copy to the counsel for the petitioners.
