The petitioner herein has alleged that Ranighat Lower Primary School and one Anganwadi Centre have been established by the State respondents in a plot of land, covered by K.P. Patta no. 170 & Dag no. 211, which has been claimed to have belonged to the petitioner. The case of the petitioner is based on a Report [Annexure-X] submitted by the respondent no. 6 to the office of the Deputy Commissioner, Kamrup [M] on 21.09.2022. It has been reported in the said Report that Ranighat Lower Primary School and one Anganwadi Centre are located in a plot of land measuring 1 Bigha 2 Kathas 10 Lessas, covered by K.P. Patta no. 170 & Dag no. 211.

The respondent authorities shall file their respective counter affidavits traversing specifically the said contents of the Report dated 21.09.2022 of the respondent no. 6.

Mr. Baruah, learned Junior Government Advocate has sought for 3 [three] weeks' time to file

such counter affidavit.
