Heard Mr. H.R.A.Choudhury, learned senior counsel assisted by Mr. I. U. Chowdhury, learned counsel for the petitioner and Mr. K.K. Parasar, learned Additional Public Prosecutor.

2. By this application under Section 482 of the Bharatiya Nagarik Suraksha

Sanhita, 2023, the petitioners have prayed for bail in connection with **Patharkandi P.S. Case No. 105/2026**, registered under **Section 109(1) / 118(2) /126(2) /351(2) /324(4) /109 /61(2) /191(3) /117(2)/3(5) of BNS, 2023.**

3. It is submitted by the learned senior counsel that on the basis of an FIR lodged by the petitioner No.6, the informant in the case where the present petitioner seeks the privilege of pre-arrest bail had been arrested and the petitioner No.5 had been injured in an assault by the informant and other colleagues. He has accordingly prayed that an interim protection be granted to the petitioners since there is enough material to show that the petitioners were attacked rather than the petitioner being the assailants.

4. Learned Additional Public Prosecutor has prayed for listing the case on 28.08.2026 to obtain the case diary.

5. Call for the case diary.

6. List again on 28.08.2026.

7. In the meanwhile, it is provided that the petitioner Nos. 5 and 6, namely, Quazi Md. Sadique Akhtar @ Sadik Aktar and Quazi Md. Salim Akhtar @ Salim Uddin shall appear before the Investigating Officer in connection with Patharkandi P.S. Case No. 105/2026 to co-operate with the investigation.

8. In the event of their arrest they shall be released on furnishing bail bond of Rs.5,000/- each with one local suitable surety of like amount each to the satisfaction of the Arresting Authority.
