The writ petitioners claim to be working as Gr-III Section Assistants in the various

division of the Irrigation Department of Govt. of Assam. Aggrieved by the provisional seniority list of Section Assistants published on 27-03-2024 by the Chief Engineer, Irrigation Department, Assam, the petitioners have approached this Court, *inter alia*, contending that the respondents have illegally ignored their seniority position while publishing the provisional seniority list.

Mr. N. Upadhyay, learned standing counsel, Irrigation Department, Assam prays for some time to obtain instruction.

Issue notice of motion returnable in 08 weeks.
