Case taken up before the Lawazima Court.

Learned counsel Ms. L. Wangsa appears on behalf of the petitioner. Heard.

Perused the records.

Perusal of the recent office note dated 30.04.2026 reveals that notice was issued to the respondent Nos. 4 & 5 via registered post with A/D mode on 04.09.2025.

However, in response to the above mentioned notice, it appears that neither the A/D cards nor any un-served notices have been received by the registry till date. Additionally, the postal tracking details regarding the said notice are unavailable in the official website of India Post. Consequently, service of notice upon respondent Nos. 4 & 5 cannot be presumed at this stage.

In view of the observations made above, the petitioner is directed to take fresh steps

for service of notice upon the respondent Nos. 4 & 5 by way of speed post mode ***[in terms of the Notification No. 85 dated 15th October, 2025 (at Flag-'N')]***.
