Heard Mr. S. P. Das, learned standing counsel, Skill, Employment and Entrepreneurship Department, appearing on behalf of the applicants. Also heard Ms. P. Sarma, learned counsel, appearing on behalf of Opposite Party No. 11.

2. This is an application under Section 5 of the Limitation Act, 1963, seeking condonation of delay of 4318 days in preferring the review petition against the judgment & order dated 15.09.2014 passed in WP(c) 3537/2012.

3. Issue notice, returnable within 4(four) weeks.

4. Since Ms. Sarma, learned counsel, has entered appearance and accepted notice on

behalf of the Opposite Party No. 11, no formal notice is required to be issued to the said respondent.

5. Learned counsel for the applicants shall take necessary steps for causing service of notice upon the rest of the Opposite Parties by Speed Post as well as by usual process within a week from today.

6. Mr. Das, learned counsel, submits that similar interlocutory application being IA(c)2998/2026 is pending before this Court and he, therefore, prays that the present interlocutory application be listed along with IA(c)2998/2026.

7. List the present interlocutory application along with IA(c)2998/2026 after 4(four) weeks on a date to be fixed by the Registry.

8. As prayed for by Mr. Das, learned counsel, Registry shall reflect the name of Mr. P. Nayak, learned Addl. Advocate General, Assam, in the Cause List as appearing on behalf of the applicants.
