Learned counsel Mr. B.K. Das appears on behalf of the petitioner. Heard.

Perused the records.

A perusal of the recent office note dated 06.03.2026 reveals that notice was issued to the respondent Nos. 6 & 7 by way of registered post with A/D on 06.01.2025.

But so far, neither the A/D cards nor any un-served notices have been received in respect of the above mentioned notice issued to the respondent Nos. 6 & 7. Further, it appears that the postal track consignment reports regarding the aforesaid notice are also not available at the Indian Post Website.

In view of the observations made above, the petitioner is hereby directed to take fresh

steps for service of notice upon the respondent Nos. 6 & 7 by way of speed post mode, in terms of the **Notification No. 85 dated 15th October, 2025 (at Flag-'N')**. The said steps shall be taken within 7 (seven) days from the date of the said order.

Let the matter be listed again before the Lawazima Court on 09.04.2026.
