Though notice was issued in this case on 21.09.2022 but the respondents are yet to file their affidavit(s) in the matter.

List this matter on **06.12.2022** for admission.

On the said date, i.e., 06.12.2022, the Deputy Commissioner, Lakhimpur and the Inspector of Schools, Lakhimpur shall apprise the Court as to whether the petitioner has been removed from the post of President of the SMDC of Tinthengia High Madrassa or not and if so, the said authorities shall

place a copy of said order of removal of the petitioner before the Court.

Further, on the said date i.e. 06.12.2022, the Mission Director, RMSA shall apprise the Court as to what action has been taken by him and his officers against the persons concerned for unused 95 bags of rice allotted to Tinthengia High Madrassa that were found damaged with insects provided under the Pradhan Mantri POSHAN Scheme.

Registry shall reflect the names of the Standing counsel, RMSA for the respondent No. 3 and the Government Advocate, Assam for the respondent No. 4.
