ORDER

Date : 30.09.2024

Case taken up before the Lawazima Court.

Learned counsel Mr. S. Difusa appears on behalf of Mr. D. Choudhury, learned counsel for the petitioner.

Learned counsel Ms. S. Mochahari appears on behalf of the respondent Nos. 10, 12 to 19, 21 to 23, 27 & 28.

Perused the records.

On a perusal of the office note dated 27.09.2024 reveals that notice was issued to the respondent Nos. 32 to 45 by registered post with A/D as well as by usual process on 21.08.2024 & 16.08.2024 respectively. The said office note further reveals that notice was also issued to the aforesaid respondents via *dasti mode* on 12.08.2024.

Now, in respect of the notice issued through *dasti mode*, it appears that the petitioner

has filed an affidavit regarding service of the said notice upon the respondent Nos. 32 to 45. As per the said affidavit filed by the petitioner, the notice in respect of the respondent Nos. 32, 34 to 45 has been duly served and the said respective respondents have acknowledged the receipt of the same by endorsing their signature on the return copy of the notice. However, in respect of the respondent No. 33, one person in her house received the copy on behalf of her, but declined to sign in the acknowledgement copy.

Further, in respect of the notice issued through registered post with A/D as well as by usual process, it appears that no A/D cards or un-served notices or service reports have been received by the concerned section as of yet.

However, it seems that the postal track consignment reports regarding the notice issued by registered post with A/D, have been tracked out and the same have been tagged with the case records. Next, on a perusal of the said reports, it has been observed that notice in respect of the respondent Nos. 32 to 45 has been delivered to the addressees on the dated mentioned below:—

On 30.08.2024:— R34, R35, R40, R41, R42, R44 & R45.

On 31.08.2024:— R36, R37 & R43.

On 04.09.2024:— R38.

On 09.09.2024:— R32, R33 & R39.

In view of the observations made above, it may be said that **service in respect of the respondent Nos. 32 to 45 has been completed.**

Accordingly, the matter is laid before the Hon'ble Court.
