ORDER

Heard Mr. JM Sulaiman, learned counsel for the petitioners, who submits that the order of this Court, dated 19.11.2025 passed in WP(C) No. 6526/2025 has not been complied with by the respondents. It may be seen that the petitioners had the apprehension that they would be released from service as Home Guard Personnels and therefore, Court had directed that *status quo* be maintained. According to the petitioners, despite the direction, the petitioners have been replaced by other personnels, namely, Home Guard Salim Uddin and Home Guard Aftabur Rahman on 01.02.2026.

Aggrieved with the same, the petitioners filed WP(C) No. 3402/2026 while the earlier writ petition filed by them is also pending. This Court, vide order, dated 25.06.2026 issued notice and stayed the impugned orders of release. According to the learned counsel for the petitioners, despite 2 (two) orders passed by this Court, the same having not been complied with, the petitioners have filed the instant contempt petition.

In view of above, issue notice of motion, returnable by 4 (four) weeks.

Petitioners to take steps for service of notice upon the respondents by speed post within 3 (three) working days.

List the matter again after 4 (four) weeks.
