Perusal of the instant case record reveals that the previous Lawazima Court vide its order dated 16.06.2025 had directed the petitioner to take fresh steps for issuance of notice to the respondent Nos. 4 & 5, within 7 (seven) days from the date of the said order.

However, from perusal of the recent office note dated 22.08.2025, it has been observed that the petitioner has not yet taken any steps for service of notice upon the aforesaid respondents, despite being directed to that effect.
