Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the recent office note dated 18.12.2025 reveals that notice was issued to the respondent Nos. 4 & 5 by way of registered post with A/D mode on 04.11.2025.

However, in respect of the said notice, it appears that neither the A/D cards nor any unserved notices have been received by the Registry.
