Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the recent office note dated 12.03.2026 reveals that notice was issued to the respondent No. 7 by way of speed post with A/D mode on 11.02.2026.

But so far, it appears that neither the A/D card nor any un-served notice has been received in response to the notice mentioned above.
