Heard Ms. S.B. Choudhury, learned counsel for the petitioners and Mr. S.M.T. Chistie, learned standing counsel for the Secondary Education Department.

2. In this petition, under Article 226 of the Constitution of India, the petitioners have prayed for issuing direction to the respondent authorities to provincialised the service of the petitioners as per recommendation made by the State Level Scrutiny Committee in its meeting held on 28.12.2021.

3. Mr. Chistie, learned standing counsel for the Secondary Education Department by producing a letter dated 13.11.2025, written by the Director of Secondary Education to the Secretary to the Government of Assam in the School Education Department, submits that the Director has forwarded a proposal to the Government for creation of two posts in respect of both the petitioners and the matter will take some time, but the same is in positive direction and therefore, he prays for listing of the matter after 4 weeks.

4. The prayer is allowed.

5. List the matter after 4 (four) weeks.

6. On that day, Mr. Chistie shall apprise this Court about the up-to-date status of the aforementioned proposal.
