A careful perusal of the recent office note dated 13.03.2026 reveals that the notice was issued to the respondent Nos. 7 & 8 by way of speed post with A/D on 17.02.2026.

Now, in respect of the above mentioned notice issued to the respondent Nos. 7 & 8, it

has been observed as follows:—

*(i) In respect of the notice issued to the respondent No. 7, it appears that neither the A/D card nor any un-served notice has been received. However, it appears that the postal track consignment report regarding the above mentioned notice has been generated and annexed with the case record at **Flag-'Y' in the Part-III file**, perusal of which reveals that notice in respect of the respondent No. 7 has been delivered on 23.02.2026.*

In view of the observations made above, it may be said that **service in respect of the respondent No. 7 has been completed.**

*(ii) Further, it appears that the notice issued to the respondent No. 8 has been received un-served with the following postal remark:— "**Addressee Left, Return to sender**".*

In view of the above, **it may be discerned that service of notice upon the respondent No. 8 could not be completed.**

Further, it has been noted that the instant matter has been fixed by the Hon'ble Court for listing on 20.03.2026.
