2. Mr. M. Chetia, the learned Government appears on behalf of all the Respondents and accepts notice.
3. As the Respondents are duly represented, extra copies of the writ petition be served upon him during the course of the day.
4. The case of the Petitioner herein is that the Petitioner is the owner of certain vehicles bearing Registration Nos. AS-01-FB-7101, AS-01-DF-0425, AS-01-EL-0019, AS-01-DF-0424, AS-01-EY-4578, AS-01-FB-7102, AS-01-LC-3736, AS-01-LC-3745 and AS-01-JC-7564. On various

occasions, the said vehicles were requisitioned by the Respondent Authorities on hire basis for the purpose of transportation and for maintaining law and order. Thereafter, the Petitioner submitted a bill amounting to Rs. 53,38,923/-, which, however, has not been paid to him. It is under such circumstances, the Petitioner has approached this Court.

5. The Respondents are directed to bring on record their stand by filing their affidavits on or before 10.01.2026 as to whether the Petitioner is entitled to any amount, and if so, when such amount shall be paid.
