Case taken up before the Lawazima Court.

Learned counsel Mr. B.B. Kakati appears on behalf of the petitioners. Heard.

Perused the records.

Perusal of the recent office note dated 12.11.2025 reveals that notice was issued to the respondent Nos. 3, 4 & 5 by way of registered post with A/D mode on 29.11.2024.

But so far, neither the A/D cards nor any un-served notices have been received. Besides the aforesaid, it appears that the postal track consignment reports regarding the aforesaid notice issued to the respondent Nos. 3, 4 & 5 are also not available at the Indian Post Website.

In view of the above, the petitioners are directed to take fresh steps for service of notice upon the respondent Nos. 3, 4 & 5 by way of speed post mode, in terms of the **Notification No. 85 dated 15th October, 2025 (at Flag-'N')**. The said steps shall be taken within 7 (seven) days from the date of the said order.

Let the matter be listed again before the Lawazima Court in the third week of December, 2025.
