Case taken up before the Lawazima Court.

None appears on behalf of the petitioners.

Perused the records.

Perusal of the recent office note dated 29.01.2026 reveals that notice was issued to the respondent Nos. 3, 4 & 5 by way of speed post with A/D on 12.12.2025.

But in regard to the above mentioned notice issued to the respondents mentioned above, it appears that neither the A/D cards nor any un-served notices have been received by the registry till date.

However, it appears that the postal track consignment reports regarding the said notice have been generated and the same have been annexed with the case record at **Flag-'R-B' in the Part-III file. Now, a perusal of the said postal tracking reports reveals that respective notices were last dispatched by the "Naoboicha S.O." as on 24.12.2025.**

From the above, **it may be discerned that the notice is yet to be served upon the respondent Nos. 3, 4 & 5. As such, it may be prudent to wait for some time for completion of service of notice upon the said respondent Nos. 3 to 5.**
