- 1.** Heard Mr. K. Jain, the learned counsel for the applicant.
- 2.** This application under Order 41 Rule 5 of the Code of Civil Procedure,

1908 read with Section 151 of the said Code has been filed by the applicant in connection with the Regular First Appeal No. 02/2025 filed by the present applicant, wherein he has impugned the judgment and decree dated 11.07.2025 passed by the Trial Court in Title Suit No. 398/2015 by the Court of learned Civil Judge (Senior Division) No. 2 Kamrup (Metro), Guwahati.

3. The learned counsel for the applicant has submitted that the aforesaid appeal has already been admitted and notices are also issued to the respondent side.

4. The learned counsel for the applicant has submitted that in the meanwhile the respondent have also initiated the execution case which has been registered as Title Case No. 73/2025, wherein the Executing Court has already issued the writ and the next date is fixed on 20.02.2026 for report.

5. Issue notice to the respondents.

6. The petitioner shall take steps for issuance of notice upon the respondent by the speed post as well as by usual mode within a day from the date of this order, returnable on 23.02.2026.

7. Considering the fact that the connected appeal has already been admitted as well as the Executing Court has issued writ in the execution case, the execution of the impugned judgment and decree shall remain stayed till the next returnable date.
