Heard Ms. J. Das, learned counsel appearing for the petitioner and Mr. K. Baishya, learned Additional Public Prosecutor for the State of Assam/respondent No. 1. Also heard Mr. A. R. Agarwala, learned counsel appearing for the respondent No. 2.

2) It is seen that the petitioner has not yet appeared before the Trial Court and straight away, she has come to this Court, praying for quashing the complaint case.

3) Therefore, the petitioner **Smti. Juri Sarma** is directed to appear before the Court of the learned Chief Judicial Magistrate, Kamrup (Metro), Guwahati in respect of Complaint Case No. 410^C/2023.

4) On her appearance, she shall be released on bail of **Rs. 20,000/-** with a surety of the like amount, to the satisfaction of the learned Chief Judicial Magistrate, Kamrup (Metro), Guwahati, Assam.

5) In this way, the earlier stay order passed by the Court remains vacated.

6) List this matter after **4 (four) weeks**.

7) On the date of listing, the maintainability of this criminal application shall be considered.
