ORDER

Date : 11.03.2026

By the order dated 17.06.2025, passed in WP(C) 5477/2021, this Court had required the Appellate Authority namely, CEM, NC Hills, Autonomous Council to reconsider the case of the petitioner in terms of the direction given in the order itself.
