Heard Mr. S.C. Pandit, learned counsel for the petitioner as well as Mr. G. Sarma, learned Standing Counsel, Home Department for the respondent nos. 2,3 and 4.

By order dated 29.03.2023, this Court directed the Superintendent of Police (Border) Darrang as well as the Superintendent of Police (Border), Nalbari to make a conjoint verification and enquiry pertaining to Ibrahim Ali, the projected father of the petitioner/proceedee, who resides at village Baruajhar under Dalgaon Police Station, District Darrang, occasionally visits his mother at village Kasimpur, P.O. Kendukuchi under Nalbari Police Station whereas mother Fatema is the second wife of said Ibrahim Ali.

It is seen that Report of the Superintendent of Police (Border), Nalbari dated 02.05.2023 which was placed before the Court on 03.10.2023, relates to only the part of the enquiry done by the Superintendent of Police (Border), Nalbari and it is silent regarding the enquiry of the Superintendent of Police (Border), Darrang.

In view of the above, pursuant to the order dated 29.03.2023, passed in this writ petition, the Superintendent of Police (Border) Darrang as well as the Superintendent of Police (Border), Nalbari are directed to submit a conjoint verification and enquiry report, as specified in the order dated 29.03.2023.

Furnish a copy of the Report of the Superintendent of Police (Border), Nalbari dated 02.05.2023 to Mr. G. Sarma, learned Standing Counsel, Home Department, Assam along with the copy of this order for his necessary use.
