satisfaction of the said authority. A direction is also made to the Superintendent of Police (Border), Nalbari that as and when the petitioner appears within the period indicated above, the biometrics of the iris of both eyes, the fingerprints of both hands and photograph of the petitioner shall be obtained, whereafter he shall be allowed to remain on bail.
