Heard Ms. S. Yasmin, learned counsel for the petitioners. Also heard Mr. P. Borthakur, learned Additional Public Prosecutor for the State.

2. This petition has been filed under Section 482 of the Bharatiya Nagarik Suraksha Sanhita, 2023, whereby the petitioners, namely, **Nayan Sarkar and Rinku Mazumder**, have prayed for granting pre-arrest bail, apprehending arrest in connection with Jalukbari P.S. Case No. 391/2025, under Section 309(4) of BNS, 2023.

3. The case arose out of an FIR dated 15.09.2025 lodged by Pranita Devi with the allegation that on that day in the afternoon one boy riding a scooty and wearing a blue shirt snatched her gold chain from her neck at Maligaon, Chariali.

4. The learned Addl. P.P. submits that perhaps there is involvement of this present petitioner in other cases as well.

5. The petitioners counsel submits that the police are seeking him out solely on suspicion.

6. Considering that the petitioners are not named in the FIR, they can be given an opportunity to record their statements.

7. Call for the case diary from the concerned police station.

8. In the meantime, in the interim, in the event of their arrest, the petitioners

named above shall be released on bail, in connection with the above case, on furnishing bail bond of **Rs. 25,000/- each** with one surety of like amount **each** to the satisfaction of the arresting authority, subject, of course, to the following conditions:-

- (i) That the accused persons shall render full co-operation to the investigation and appear before the I/O, making themselves available for examination,
- (ii) That the accused persons shall not hamper or tamper with evidence,
- (iii) That the accused persons shall not misuse their liberty to commit any offences and illegal activities.

9. In case of violation of any bail conditions, bail will be liable to be cancelled.

10. List the matter again on **16.12.2026**.
