3. Extra copies of the writ petition be served upon them within (three) days.

The case of the petitioner herein is that the petitioner was awarded the work of Installation of Sound System, Projector, and Electrification in the Auditorium of the Office of the Registrar of Cooperative Societies, Assam (Providing internal & external electrification of Auditorium hall, Air Conditioner, Ceiling fan, wall fan, LED false ceiling light, 60 Nos. of USB charger & Panel Board etc.-Phase-I by the respondent No. 4. The petitioner successfully completed the aforesaid work, and in this regard the respondent No. 4 issued a Work Completion Certificate dated 04.05.2023. Subsequently, the respondent No. 4, vide letter dated 01.02.2023, submitted the final bill amounting to Rs. 20,50,114/-

to respondent No. 3 for release of payment in favour of the petitioner, however, the same has not been paid till date. It is under such circumstances, the petitioner has approached this Court.

5. The respondents are directed to bring on record their stand by filing the affidavits on or before 16.02.2026.
